ALLEGATIONS

It is alleged Subject Samuel Aldama, while off duty on October 2, 2015, brought discredit to himself and the Department when he intervened in a criminal investigation/traffic stop involving police officers from the Orange Police Department, and former Los Angeles County Deputy Sheriff Mizrain Orrego. Subsequent investigation revealed that Subject Aldama knowingly made misleading statements to the arresting officers, as well IAB investigators during the Administrative Investigation.

SUMMARY OVERVIEW OF INCIDENT

On October 2, 2015, former Deputy Sheriff Mizrain Orrego was arrested for driving under the influence (DUI) of alcohol by Orange Police Department Officers. During the DUI investigation, Subject Aldama drove up to the scene and at some point he was contacted by officers at the scene. During Subject Aldama's conversation with the officers, Subject Aldama told officers that he had called Compton station, and that units were responding. Subject Aldama also told officers that he was at the "Tilted Kilt" to celebrate someone's promotion. Subject Aldama's statements were captured on a dash cam recording device.

As a result of Mizrain Orrego's arrest, an Administrative Investigation was conducted. Subject Aldama was later interviewed twice as a witness by Internal Affairs Bureau

(IAB), and as a subject, after the investigation revealed that he made misleading statements to the Orange Police Department officers and IAB investigators.

During the IAB witness interview [Exhibit A] on February 24, 2017, Subject Aldama admitted to telling officers that he was at the "Tilted Kilt" restaurant for someone's promotion, but in this interview he admitted that nobody in fact had been promoted. Subject Aldama also stated he did not recall seeing anyone from Compton Station at the "Tilted Kilt" restaurant. He also admitted that he did not call Compton Station as he initially told officers.

During the IAB witness interview [Exhibit B] on April 13, 2017, Subject Aldama admitted that he told officers that someone had promoted, but in this interview he again admitted that no one had been promoting.

On August 14, 2017, Subject Aldama was interviewed as a subject by Lieutenant Joseph J. Williams of Compton Station. During the interview, Subject Aldama viewed dash cam audio and video footage [Exhibit C] of Mizrain Orrego's traffic stop. Subject Aldama confirmed that he told the officers he had called Compton Station and that patrol units were responding. He later also admitted that he never called Compton Station, and that no units were responding.

Deputy Orrego's arresting officer, Lucia Zvonaru, was interviewed as a witness in the original investigation (IV2390151), her interview transcript is included with this investigation as **Exhibit D**.

Lastly, Subject Aldama acknowledged that he made a poor decision and he expressed remorse for his actions.

Williams: And how long have you been here at Compton?

Aldama: I've been here approximately two years and a half, sir.

Williams: Do you know an individual named Mizrain Orrego?

Aldama: Yes I do, sir.

Williams: How do you know him?

Aldama: I worked custody with him and we came out together training here at

Compton Station.

Williams: So this incident that we're talking about involves Mizrain, he's the one that

stopped on the traffic stop, correct?

Aldama: Yes, sir,

Aldama: Well, he's my radio car partner, sir.

Williams: All right and you guys were partners how long?

Aldama: A little bit over a year, sir.

On February 24, 2017 this year you were interviewed as a witness by investigators from Sheriff's Department Internal Affairs Bureau commonly known as IAB, correct?

Yes, sir.

During that interview you answered questions about what you witnessed

to the Tilted Kilt? Well, let me do this. At the bottom of your transcripts on page three, at the bottom of the transcript Sergeant Adams asked, "So when you told Officer, I don't know how you pronounce her name, Vana...

Marangell: Officer Z will be fine.

Williams: Officer Z, that it was a friend promoting to Sergeant, were you certain

that's what was going on? And you answered, "Well, I mean it was, it was just a question. I have to say yes." Was there a promotion party that

night?

Aldama: I don't think it was a promotional party, sir.

Williams: What type of party did you think it was?

Aldama: It was just a gathering probably.

Williams: Just a gathering for, a gathering for who?

Aldama: For someone, I, I didn't, I don't know who it was. But it was a gathering.

Williams: Was it a gathering for personnel from Compton Sheriff's Station?

Aldama: I believe so, sir.

Williams: You believe so?

Aldama: But I'm not, I'm not sure whose it was, sir.

Williams: So why did you go?

Aldama: I went just like I said for a gathering, sir, but when I arrived there was, I

don't know if it was going on, it was probably done by then or something.

Williams: So in a portion of the video you told the officer that it was a promotion

party but you weren't sure.

Aldama: I wasn't sure if it was a promotional party.

Williams: You believed there was just some sort of gathering and that's why you

went?

Aldama: Yeah, some, some sort of gathering, probably I, I chose the wrong

promotion word, sir. It was just a gathering, sir.

Williams: Do you know an individual named Lieutenant Mitry?

Aldama: Yes, sir.

Williams: How do you know Mitry?

Aldama: I know Mitry because he's the, he was the Watch Commander.

Williams: Here at Compton Sheriff's Station?

Aldama: At Compton Sheriff's Station, sir.

Williams: So October 2nd that night at the Tilted Kilt, at any time that evening did you

see or talk to Lieutenant Mitry?

Aldama: I don't remember talking to Lieutenant Mitry, sir.

Williams: Do you remember seeing him there at the event?

Aldama: No, sir.

Williams: Do you know an individual named Mark Lopez?

Aldama: Mark Lopez? I believe he was a sergeant here as well, sir.

Williams: You believe or?

Aldama: He was a sergeant here at Compton Station at one point, sir.

Williams: So once again October 2nd, that night did you see or talk to Mark Lopez at

all?

Aldama: I don't remember seeing or talking to Mark Lopez, sir.

Williams: We watched a video the very first segment is the initial traffic stop. When

did you first observe the patrol car from Orange PD?

Aldama: I want to say as I was nearing the intersection I saw a vehicle behind me.

Williams: Was that vehicle parked off to the side or anything or you were just driving

and you, when you were in the intersection and you saw a vehicle behind

you?

Aldama: Yes, sir, I'm driving and, and it might have been some more vehicles but it

appeared it came out from somewhere. And it was just...I'm not even

sure from where but it was, it was fast.

Williams: From your perception?

Aldama: From my perception, sir.

Williams: How did you come in contact with the officers from Orange PD?

Aldama: After the traffic stop, sir.

Williams: So we watched a video, we watched the female officer talk to her partner

and she points in a direction and she says, I'm gonna go talk to him, and she kind of trails off. Is that your first contact with the officers that night?

Aldama: I mean from the vid--, I'm not sure, sir, from, from what the video....

Williams: Well, let me ask you this at one portion you had a conversation with the

female officer and probably one of her partners, correct?

Aldama: Yes, sir.

Williams: Is that your first contact with them or did you talk to them before that?

Aldama: I think I talked to them before that, sir. Before the, that video.

Williams: What did you guys talk about?

Aldama: I'm not sure but it was something along the lines of if I knew Deputy

Orrgeo.

Williams: Then she went back to the traffic stop and finished?

Aldama: And she went, that was after the traffic stop.

Williams: It was after the traffic stop. So during the traffic stop where, where were

you?

Aldama: During the traffic stop I was at a red light and I, I parked away from the

traffic stop.

Williams: And you observed from a distance?

Aldama: Yes, sir.

Williams: How far do you think?

Aldama: It was four, four to five cars away from the traffic stop. From, from along

that line.

Williams: At any time during that, did you interfere at all? Did you, did you make

contact with them? Did you approach the traffic stop?

Aldama: No, sir.

Williams: So while they were conducting the, having a conversation with Mizrain

Orrego or conducting FST's during their detention did you make contact

with them at all?

Aldama: During their detention, not, not that I can remember, no, sir. I did not.

Williams: So at one point the officer comes up and they start talking to you and they

tell, she says words to the effect of, do you know what's going on here? And then you say "I saw the handcuffs go on." Do you remember that

from the video? You want to play it again or want to, or you...?

Aldama: Yeah, I don't re--....

Marangell: Yeah, I don't recall that either. We'll, I mean I, we can take your

representation if that's what occurred for purposes of this interview.

Williams: Okay, yes, okay. So at some point she told you, well let me ask you this.

You've, you worked here in Compton for two and a half years?

Aldama: Yes, sir.

Williams: Have you ever arrested anyone for DUI?

Aldama: No, sir.

Williams: Have you ever observed anyone be arrested in the field for DUI?

Aldama: Yes, sir.

Williams: Have we, what's our procedure? If we arrest someone for DUI?

Aldama: Well, I mean, handcuffs have to be, there's gonna be handcuffs, sir.

Williams: And then what happens after that?

Aldama: Well, he's gonna be transported or, or some, along those lines.

Williams: To a patrol station and booked?

Aldama: To a patrol station and booked, yes, sir.

Williams: So when you were talking to the officers and they told you Mizrain was

going to receive a citation and be released, what did you believe that to

mean?

Aldama: I believed to me he was gonna get released right there and then, sir.

Williams: That he would get released right there?

Aldama: Yes, sir.

Williams: Did you believe that he was being arrested for DUI? Or what did you

believe?

Aldama: Yes, I mean when I saw the handcuffs of course I saw that, that he was

going to be arrested for, for something, sir.

Williams: What do you mean for something?

Aldama: Well, for, for, I mean for sure the DUI, sir.

Williams: So when she said she's gonna be issued a citation and be released did

that seem strange to you?

Aldama: Well it did because I thought he was going to get released right there and

then, sir.

Williams: Released meaning let go?

Aldama: Like released on the field, sir.

Williams: Did you believe at that point that he was going to be released and not

arrested?

Aldama: I believe he was going to be arrested, released in the field. I honestly took

it as when you take someone into like, let's say possession of drugs or whatever. That you arrest them and then cite them on the field, sir.

Williams: But you were, you were under the impression that he was going to be rel-,

he was going to be arrested for DUI and possibly receive a citation and

released in the field?

Aldama: Yes, sir.

Williams: But that's, that's not our procedure for the Sheriff's Department?

Williams: So let's go to page five of the transcript. The second, the second

interview. The April 13th interview. I take that back, go to page four.

Page four, at the bottom of page four.

Aldama: Okay.

Williams: You made a statement to the officers that you heard on the videotape that

you had made a phone call to the patrol station, to Compton's Sheriff's Station and radio cars were coming. Okay, so you were, in your first interview they asked you about that statement and you told them that was

incorrect, correct?

Aldama: I'm not, I'm not sure if I....

Marangell: Where are you pointing out where he says to the....

Williams: Well, let me ask you this. You told them the patrol cars were coming

correct?

Aldama: Yes, sir.

Williams: Were there patrol cars coming from Compton Sheriff's Station?

Aldama: No, sir.

Williams: You told them you made a phone call, correct?

Aldama: Yes, sir.

Williams: But you didn't make a phone call?

Aldama: No, sir, I....

Marangell: Oh, I see where you're saying, okay.

Aldama: ...okay.

Williams: So let me ask you this. What did you hope to accomplish by making that

statement? What did you hope that they would do?

Aldama: What I, what I, what my intent was to eventually make a phone call, sir. I

know we had to make a phone call for the incident and, and if he was gonna get released in the field maybe someone could, could I don't know if that would be approved but either a patrol car or somebody else to come

and, and help us out, sir. I was nervous but in no way I was trying to intervene with any type of an investigation, sir.

Williams: Because let me ask you, so in the beginning the officer made, said words

to the effect he's gonna be, she's gonna, she asked you hey, you know what's going on? You saw the handcuffs go on, you believe he was being

arrested for a DUI correct?

Aldama: Yes, sir.

Williams: They told you he was going to receive a ticket and be released in the field

so at that point he was gonna be held accountable for the DUI.

Aldama: Yes, sir.

Williams: Then you made the statement that patrol cars are coming. You kind of

repeated it a total of it, a version of it almost three times.

Aldama: Yes, sir.

Williams: So my question to you is what did you expect, what did you hope they

would do by saying that?

Aldama: I wasn't hoping for them to stop their investigation at all, sir.

Williams: You were not hoping that?

Aldama: No.

Williams: What did, what did you want them to do?

Aldama: My thing was either if he was going to release in the field either take him

home or something. He wasn't gonna be able to drive his vehicle of

course after that.

Williams: But it wasn't your intent to impede their investigation?

Aldama: Absolutely not, sir. I was not trying to intervene in any type of way in their

investigation, sir.

Williams: And you've conducted traffic stops in the field, correct?

Aldama: Yes, sir.

Williams: So as a Deputy Sheriff, how would you react if a stranger approached

your traffic investigation?

It is important to understand that while this recording depicts visual information from the scene, the human eye and brain could perceive some things in stressful situations differently than a camera records them. So this photographic record may not reflect how the involved personnel actually perceived the event. The recording may depict things that personnel did not see or hear. Personnel may have seen or heard things that were not recorded by the camera. Depending on the speed of the camera, some action elements may not have been recorded or may have happened faster than personnel could perceive and absorb them. 



Is that correct?
